**Subject: Constitution of the Executive Committee of the Tripura Urban Planning and Development Authority (TUDA)**

In compliance of notification No.F.3 (09)-TUDA/Project/2021/P-I/686-92 Dated, Agartala, 02/06/2023(copy enclosed) and in exercise of the powers conferred under Section 23, read with Sections 22, 25 and other enabling provisions of the Tripura Urban Planning and Development Act, 2018, the Tripura Urban Planning and Development Authority (TUDA) hereby constitutes the Executive Committee for ensuring efficient discharge of the functions of the Authority, with the following composition, powers, duties, and conditions:

**1. Constitution of the Executive Committee**

The Executive Committee of TUDA shall consist of the following members:

7.	Deputy/Assistant Director, Industry & Commerce	Member

The Authority may co-opt subject-matter experts as invitees for specific agenda items.

**2. Financial Limit (Acceptance of Tender) of the Executive Committee**

The Executive Committee shall exercise the following financial power (Acceptance of Tender) on behalf of the Authority, subject to the Act, rules, and applicable notifications:

- Acceptance of Tender in case of project up to Rs. 50.00 crore on Recommendation of Technical Committee - 1
- Acceptance of Tender in case of Consultancy up to Rs. 15.00 crore on Recommendation of Technical Committee - 1
- Any other powers specifically delegated by the Authority through resolutions or notifications.

**3. Duties and Functions**

The Executive Committee shall:

- Acceptance of tenders and award of contracts for works, goods and services within the financial limits delegated under the Notification of Financial and Technical Powers under TUDA, as amended from time to time.

- b. Approval of procurement actions after consideration of recommendations of the Technical Committee constituted vide notification No.F.3 (09)-TUDA/Project/2021/P-I/686-92 dated 2<sup>nd</sup> June 2023
- c. Approval of administrative and contractual matters necessary for execution of development works and projects.
- d. Authorization to the Commissioner, TUDA, to sign agreements, contracts, work orders, and related instruments on behalf of the Authority.
- e. Approval of variations, extensions of time, and other contractual decisions withing delegated powers.
- f. Any other powers specifically delegated by the Authority through resolutions or notifications.
